Driving and Parking Regulations

The regulations listed below are issued to promote safety and order in the driveways and parking lots around the school. It should be clearly understood that failure to comply with the regulations and conditions would mandate revocation of the driving privilege.

1. Any student who wants to drive to school and use the school parking lot must register his/her vehicle by properly completing this form.
2. Any motor vehicle parked in the school parking lot must display an official school-parking permit. These permits will be issued only upon the completion and approval of this registration form. The cost for the permit is \$50 this year.
3. Vehicles without a parking permit will receive a warning the first time. The second time the vehicle will be towed at the owner's expense.
4. The maximum speed limit in all driveways and parking lot is 10 mph. All traffic laws are enforced.
5. Students may park in the designated parking areas only. Violations will result as follows: First offense – 2 week driving suspension. Second offense – vehicle will be towed at owner's expense. Parking in a fire lane is a serious offense; the first violation will be a warning, the second time the vehicle will be towed at the owner's expense.
6. Students may not go to their vehicles between 8:10 am and 2:46 pm unless they are leaving the school property with an approved early dismissal, or unless they have permission from the principal or designee.

7. Students must drive on school property with extreme caution and consideration. Any evidence of reckless or careless driving will result in the suspension of driving privileges. Drivers are to obey parking lot supervisors.
8. Should it be necessary to revoke a driving privilege and the student involved is found driving on school property, it will be considered a very serious violation. The first violation will result in an additional suspension of driving privileges for a period of time determined by the principal. The second violation will result in revocation of driving privileges. It also will be considered insubordination, and the student may be suspended from school for a period of time determined by the principal or designee.
9. Students must avoid any unnecessary noise while driving on school property.
10. Observe all driving and parking regulations printed in the Student-Parent Handbook and laws passed by the City of Watertown and the Board of Education.
11. In event of a repeated and/or serious violation of parking and driving rules, a complaint may be filed by the school with the Carver County Sheriff's Department.
12. **School buses have the right of way at all times.** The first violation will result in a warning. The second violation will result in a two-week suspension of driving privileges. The third violation will result in suspension of driving privileges for four weeks. A further violation will result in suspension of driving privileges for the remainder of the school year.

Parking in visitor, posted reserve, itinerant, or handicap spaces will result in immediate towing. I/we understand that the vehicle will be towed at the owner's expense.
